o Brandi motioned to approve minutes from June. Passed unanimously. •

TREASURY REPORT

o Dana officially resigned today per Jon and was unable to give a treasury report.

• OLD BUSINESS

- HOA Services of Oklahoma
 - Setup with the property management company requires a change of bank to F&M Bank in Piedmont, OK

- o Brandi documented issues and shared a quote for road maintenance on the NE side of Pecan Creek Drive from Harrah Newalla to Acorn drive.
- Brandi documented issues on Winding Creeks and 18551 Rolling Oak to be addressed by AtGrade Construction.
 - o Jon will obtain a quote from At Grade Construction for drainage ditches.
- o The board will obtain quotes for the tinhorns that run under the roads at Acorn and Walnut drive to be cleaned from various service providers that can be identified.
- o The Board was unwilling to move forward with any of the quotes presented at this point.

ISSUE: potholes at entrance; crack seal deteriorating; needs regular maintenance before it requires extensive work

TJ Campbell – Stryker Asphalt Quote(s)

\$5,269.26 Crack Seal and Seal Coat of entire roadway

*Stryker Asphalt advised that the Seal Coating of the entire roadway is the most crucial element to the maintenance of the roadway and should be done every two to three years; and if it is not maintained properly it will require an asphalt overlay which is upwards of \$45,000.
